MOSS VALE MEN'S SHED WORKPLACE HEALTH AND SAFETY POLICY

Obligations

This organisation is committed to a policy enabling all work activities to be carried out safely, and with all possible measures taken to remove (or at least reduce) risks to the health, safety and welfare of Shed members, authorised visitors, and anyone else who may be affected by our operations.

Responsibilities

<u>The Shed</u>

The shed will provide and maintain as far as possible:

- A safe working environment,
- Safe systems of work,
- Plant and substances in safe condition,
- Facilities for the welfare of members,
- Information, instruction, training and supervision that is reasonably necessary to ensure that each member is safe from injury and risks to health,
- A commitment to consult and co-operate with members in all matters relating to health and safety in the workplace, and
- A commitment to continually improve our performance through effective safety management.

Members

Each member has an obligation to:

- Comply with safe work practices, with the intent of avoiding injury to themselves and others and damage to plant and equipment,
- Take reasonable care of their own health and safety and the health and safety of others,
- Wear personal protective equipment and clothing where necessary,
- Comply with any direction given by management in relation to health and safety,
- Not misuse or interfere with anything provided in the interest of health and safety,
- Report all accidents and incidents on the job immediately, no matter how trivial, and
- Report all known or observed hazards to the Workshop Manager.
